The school is a project-based, multiage setting serving kids 4K- 8th grades. Current enrollment is approximately 140. The curriculum has four focal points; environmental education, agriculture, STEM, and the arts. Students engage in a variety of student led projects with guidance from the advisors (teachers). Literacy and Math are taught using the legacy model during the mornings; science and social studies are in the afternoon during project time with the inclusion of the focal points.
